Conditions for the validity of Fire Safety Certificate

- 1. All the means of escape shall be kept free of all the type of obstruction all the time
- 2. All the employees shall be acquainted with the use and maintenance of all fire equipments and method of smooth and speedy safe evacuation of occupants in case of emergency.
- 3. All the fire fighting equipments shall be maintained in perfect working condition all the time and any lapse rendering non-functional of fire safety measures, management shall be responsible.
- 4. The clarification with regards electrical installation, ventilation, structure stability set back areas occupancy and constructional deviation in building etc may be got verified from the authorities concerned.
- This Fire Safety Certificate cannot be treated in any case for regularizations of unauthorized construction unauthorized use of land if any.
- 6. The owner / occupier shall submit a declaration every year in form 'K' provided in the first schedule of Delhi Fire Service Rule 2010. The form is available on www.dfs.delhigoyt.nic in
- 7. The owner /occupier shall apply for renewal of this fire safety certificate to the Director in form J' [sub Rule (1) of Rule 37] along with a copy of this certificate, six months prior to its expiry.
